## **How to Consign Alpaca for Sale to Cashmere Connections**

### **Packaging your clip**

1. Consolidate your clip into a nylon wool pack.

### **Mark Bales Clearly:-**

1. To:

Bacchus Marsh,  
Victoria. 3340
2. From: Grower's name or trading name, address and **phone number**.
3. If more than one bale mark the outer number and total number of outers on each bale.  
eg. bale 1 of 3, bale 2 of 3, bale 3 of 3.

### **Consignment Note.**

1. Please fill out the consignment note in clear legible writing.
2. Use the consignment note to indicate the lots/fleeces in each bale / outer.
3. Keep a **copy** of the consignment note for your own records.
4. If more than one consignment is being delivered, please complete a separate consignment note for each consignment.

### **Terms and Conditions of Sale**

- 1: In submitting cashmere for sale to Cashmere Connections Pty Ltd, the seller declares that the said fibre is free from any bills of sale, liens, charges or other encumbrances.
- 2: Cashmere Connections' official weights will be deemed to be the weight of the fibre received.
- 3: That all testing requested by the seller will be paid for by the seller.
- 4: That any government levies for which the seller is liable will be deducted from the gross proceeds of the fibre sold.
- 5: A seller registered for GST (and has supplied an ABN) agrees to the following.
  - a) Cashmere Connections can generate a Tax invoice for the supplies where appropriate.
  - b) The registered seller shall not issue tax invoices in respect of the supplies for which Cashmere Connections has generated an invoice.
  - c) The registered seller is registered for GST.
- 6: If the seller does not supply an ABN or sign the declaration that the supply is private or hobby related, Cashmere Connections must send 48,5% of the payment to the TAX office.
